10 YEAR LIMITED WARRANTY

## COVERAGE

This Mattress Protector warranty is effective for ten (10) years from the date of purchase. GBS Enterprises, Inc. warrants that the new Mattress Protector will protect your new mattress from covered stains for ten (10) years after the date of purchase. If a rip, tear, burn, or stain occurs that is covered by this warranty, GBS Enterprises, Inc. will at their sole discretion clean, repair, or replace the mattress with one of comparable value at no charge.

To qualify for warranty coverage: (i) You must report damage within 5 days of occurrence; (ii) the Mattress Protector must have been purchased on the same sales receipt as the subject mattress from American Signature; (iii) you must present the original sales receipt for the mattress and the Mattress Protector; (iv) you must be able to demonstrate that the Mattress Protector was in place on the mattress when the stain occurred; and (v) you must provide the date of the stain or damage. You are responsible for any and all transportation costs associated with this warranty. Claims made in connection with this warranty must be submitted on or before the 10<sup>th</sup> anniversary of the date of purchase by contacting GBS Enterprises, Inc. Warranty Department at 1006 E. Maple Street, Sutton, NE 68979 or by calling 888-456-7821. Before replacing the mattress, GBS Enterprises, Inc. reserves the right to examine the mattress and send a cleaning kit or a professional cleaning company (or both) to remove the stain. Claims are considered open for a period of 90 days from the original claim date. In the event that the consumer has not executed their duties under the warranty process within that time frame, GBS Enterprises, Inc will consider the claim closed and the warranty shall end.

## EXCLUSIONS

**THIS WARRANTY DOES NOT COVER OR APPLY TO:** (i) Mattress Protectors used for commercial, institutional, or rental purposes; (ii) Mattress Protectors that have been neglected, mishandled, or abused; (iii) stains or other damage caused by nail polish, inks, cosmetics, bleach, non-food related grease, corrosives, chemicals, alcohol, or dyes; (iv) stains or other damage occurring prior to or during delivery or while the mattress is in or being moved into or out of storage or being moved between residences; (v) stains or other damage caused by, or the result of, mold or mildew; (vi) damage caused by animal beaks, teeth or claws; (vii) stains or other damage caused by or related to fire (including water damage), smoke, flood or other natural disaster, theft or vandalism, or any other loss that is covered under an insurance policy; (viii) stains or other damage caused by structural problems or appliance malfunctions such as but not limited to leaks from air conditioners, skylights, roofs, water heaters, or water pipes; (ix) odors or stains of unknown origins; (x) claims established under this warranty more than five (5) days after occurrence of the stain or damage; (xi) Mattress Protectors that have been laundered with bleach or bleach added detergent.

**THIS WARRANTY ONLY COVERS YOUR MATTRESS AND YOUR MATTRESS PROTECTOR. IT DOES NOT COVER ANY CONSEQUENTIAL DAMAGES (INCLUDING ANY OTHER PROPERTY DAMAGE.)** Some states do not allow (i) limitations on the duration of any implied warranty and/or (ii) the exclusion of limitation of incidental or consequential damages, so the above limitations and exclusions may not apply. This warranty gives you specific legal rights and you may also have other rights, which vary from state to state.

In the event that the mattress is replaced, all obligations under this warranty will end.
