

ReCover Program Specifications

Product shall be recovered as per the guidelines mentioned below.

Product Condition Requirement

Carpet Types And Condition

Carpet shall meet the requirements below to be accepted for take back program.

- Mohawk Take Back partners will accept broadloom carpet or carpet tiles
- · Carpet must be free of debris and trash
- Carpet must be dry
- · Carpet cannot be contaminated with:
 - Fluids
 - Chemical or pharmaceutical contaminants
 - Asbestos
- Client Personnel or General Contractor to send material samples upon request if required.

Carpet Reclamation Preparation For Shipping And Reclamation Freight

Carpet Removal-Broadloom

- · Client Personnel or General Contractor to package material as per guidelines for transport.
 - · Remove used carpet in large pieces, roll tightly, and pack neatly in truck
 - · Material to be stacked from floor to ceiling
 - Broadloom and carpet tile must be separately packaged for transport
- · General Contractor or Client Personnel to notify ReCover point of contact for any special freight needs.
 - Special Lift gates, Drop trailers, special truck sizes, city truck size, city truck, etc.

Carpet Removal-Carpet Tile

- Client Personnel or General Contractor to package material as per guidelines for transport.
 - · Remove used carpet tile and stack neatly on pallets.
 - Carpet tiles must be secured to the pallet for transportation
 - · Do not stack higher than 6 feet on pallets
 - Carpet tile and broadloom must be separately packaged for transport
- General Contractor or Client Personnel to notify ReCover point of contact for any special freight needs.
 - Special Lift gates, Drop trailers, special truck sizes, city truck size, city truck, etc.

Container Handling

 Client Personnel or General Contractor to place carpet in approved Carrier trailer. Client Personnel or General Contractor to ensure trailers are fully enclosed and shall be kept locked or supervised.



• Client Personnel or General Contractor shall use effective packing techniques outlined to maximize the amount of material in the trailer. On average the following amounts are the related container capacities.

Container Size	Broadloom Capacity	Tile Capacity
53' ft	8,000 sy	4,444 sy
28' ft	4,800 sy	2,666 sy

Container Removal

• When trailer is full, General Contractor or Client Personnel to contact ReCover point of contact to schedule trailer pickup and drop-off of replacement trailer if needed. If trailer is locked for security purposes, remove the lock prior to pickup.

Reclamation Certificate

• The Mohawk ReCover point of contact to issue a reclamation certificate once used carpet is removed from the job site location and recycling/landfill diversion partners have confirmed receipt and processing of material.

Reclamation Fees

Reclamation Fees

- ReCover point of contact to provide recycling/landfill diversion fees to General Contractor or Client Personnel.
- · Cost to be calculated per project based upon:
 - Material Type, Quantity, Recycling facility destination
 - · Freight
 - Client is responsible for any additional costs associated with special freight needs such as lift gates, drop trailers, special truck size, city truck size, loading and unloading material, etc.
- · Rates are good for 30 days

Reuse Option (Alternative)

- Material that is in good condition is donated to local Non-Profit(s) in the job-site community. General Contractor or Client Personnel to contact ReCover point of contact to coordinate material donation. Non-Profit representative must inspect and pre-approve all material to be donated.
- · Material in good condition is defined by:
 - · Carpet must be free of debris and trash
 - · Carpet must be dry; wet or damaged carpet will not be accepted
 - Carpet tile must be whole pieces; no cuts will be accepted
 - Carpet tile must be shrink-wrapped and palletized
 - · Carpet cannot be contaminated with fluids, chemical or pharmaceutical contaminants, asbestos
- · General Contractor or Client Personnel to send samples or pictures upon request
- · Reuse options vary and are reviewed on a project by project basis.
 - Client is responsible for costs associated with removal of material as well as packaging of material for pick-up or transport to donation site
