LIMITED WARRANTIES

Manufacturing Defects Warranty

Ensures that during the period of the warranty, flexitec flooring will be free from manufacturing defects.

Contraction & Expansion Resistance Warranty

Ensures that your floor will resist contraction and expansion, excluding areas of extreme localized temperature variations.

Curl-Crack-Rip-Tear-Gouge Resistance Warranty

Ensures that your floor will resist curling, cracks, rips, tears, or gouges from normal household use.*

Waterproof Warranty

Ensures that your flooring will be 100% waterproof, and the structural integrity of the floor will not be significantly diminished by exposure to water.

Mold & Mildew Resistance Warranty

Ensures that your floor will resist the effects of mold, mildew and/or alkaline substances.**

Scuff Resistance Warranty (on products with a polyurethane lacquer)

Ensures that your floor will resist permanent scuffs from shoe soles.

Household Stain Resistance Warranty

Ensures that your floor will resist permanent stains from common household products, excluding permanent marker, permanent dyes, and finishing stains.

Yellowing Stain Resistance Warranty (on products with a polyurethane lacquer)

Ensures that your floor will resist permanent stains or yellowing from foot traffic, including asphalt track-off.***

Wear Resistance Warranty

Ensures your floor will resist wearing through the wear layer under normal household conditions.****

* Normal household use is defined as common daily activities in the home, excluding pet damage such as chewing, digging, clawing, etc.

** A floor discolored due to mold or mildew growth will be replaced only one time. If the replacement floor fails in the same manner, the site conditions may not be acceptable for the installation of sheet vinyl.

*** A floor discolored due to asphalt track off will be replaced only one time. If the replacement floor fails in the same manner, the site conditions may not be acceptable for the installation of sheet vinyl.

****Wearing through is defined as complete loss of the wear layer so that the printed pattern or design is altered.
Gloss reduction is not considered wear and is not covered by this warranty.

OBLIGATIONS OF OWNER

Owner must submit notice of all claims under these warranties to the retailer within the specified warranty period. Claims must be submitted in writing. Owner must submit proof of purchase with claim. The original owner agrees to provide proof of compliance with recommended installation and maintenance procedures when a claim is filed.

GENERAL TERMS AND EXCLUSIONS

Flexitec sheet vinyl flooring is warranted as indicated above in continuous climate controlled interior environments. The following general terms and conditions apply. If you have questions regarding the warranty information, please contact your retailer or IVC sales representative.

1. These warranties apply to flexitec sheet vinyl flooring when installed and maintained in accordance with our most recent installation and maintenance procedures. For the most up-to-date procedures, please visit www.IVCfloors.com.
2. These warranties apply only to the original owner and the first installation of the product and are non-transferable. The "original owner" is the person stated as the buyer on the purchase document(s). This warranty applies only to first quality flexitec sheet vinyl flooring purchases.
3. Understand that manufacturer warrants the first quality products – which are used only for recommended use – will perform properly for the stated warranty period when installed in accordance with flexitec Installation Guide over approved substrates and underlayments and using the recommended adhesives and seam bonds/sealers. The warranty period, when valid, begins on the date of the original installation.
4. IVC will, at its option, repair or replace product not meeting the above listed warranties. When replacement of the flooring is made, only new material from the current product range at the time of the claim will be supplied by the distributor or retailer. There will be no other form of compensation. IVC's responsibility under this warranty only applies to hidden defects that were not visible before or during the installation of the flexitec sheet vinyl flooring. Material installed with visible defects is considered accepted by the owner.
5. These warranties do not apply to flexitec sheet vinyl flooring that has been subject to abnormal use or conditions or abused in any way. "Abnormal use or conditions" includes but is not limited to damage from plumbing or appliance leaks, storm, or flood; damage from smoke, fire, or other casualty events; damage caused by negligence or improper alterations of the original manufactured product. "Abuse" is any use of the flooring that is unreasonable considering the normal and expected uses of flexitec sheet vinyl flooring in a residential or light commercial environment. The feet of furniture must always be covered with appropriate protective material. Chairs, sofas, or furniture with castors must be fitted with soft rubber wheels and placed on an adequate protective mat or be placed in protective castor cups.
6. Walk-off mats must be placed at all exterior entrances to protect flexitec sheet vinyl flooring from soil, grit, deicers, asphalt sealers, and other contaminants capable of damaging flexitec sheet vinyl flooring. Suitable walk-off mats should contain both soft and firm fibers to facilitate removal of wet or solid contaminants from shoe soles. An extra set of walk-off mats should be available for each entrance so the mats can be replaced and cleaned weekly during routine maintenance, or more often depending upon site and weather conditions. This routine will prevent walk-off mats from becoming the source of tracked-on contaminants. Walk-off mats should be large enough to allow adequate soil removal.
7. These warranties do not apply to damage from exposure to extreme heat or sunlight exposure, dryness, or stains as a result of chemical or industrial products (*other than recommended cleaning products*). Windows coverings should be used during periods of intense sunlight to avoid intense heating of flooring product.
8. These warranties exclude damage caused by hydrostatic pressure (*water or moisture under the floor that is transmitted to the surface through exerted pressure*) or other conditions that result in water or moisture below the floor.
9. Material must be checked carefully for defects before and during installation and under sufficient lighting. Products with visible defects must not be installed under any circumstances. Color and gloss issues resulting from material added to an existing installation at a later date and non-warranty related repairs are excluded from coverage.
